SD 1064-C-TE was recontacted on 9/6/67, and he furnished the following information on La Cosa Nostra (LCN):

I. LOS ANGELES DIVISION

Informant advised that on 9/1/67, he received a telephone call from JOE-ADAMO, Capo, San Diego Branch of the LCN Family, requesting a meeting with the informant. ADAMO advised that it was very important and that he had to meet with the informant prior to 1:00 p.m. that date. Informant contacted ADAMO at his bar, The Exchange Club, in San Diego, at which time ADAMO advised him that they had received instructions from the Commission on how they should proceed in selecting a new boss for the Los Angeles Family. He advised that these instructions were that they should have an administrative meeting, and that these individuals should make a selection regarding who should succeed FRANK DESIMONE, deceased, as the new boss of the LCN Family. ADAMO stated that they had had their conference and had selected the former underboss, NICK LICATA, as the new boss for the Los Angeles Family. ADAMO further advised that instructions were, after a new boss had been selected, each member was to be
