on 8/27/67, advised "LITTLE JOE" LNU was in Kansas City,  
Missouri, from 8/24 to 8/26/67. NICK CIVELLA, CARL DE LUNA  
and ANTHONY CIVELLA were with "LITTLE JOE", who was  
described to CI as being from "out of town" visiting NICK  
CIVELLA re business reasons.

"LITTLE JOE" is probably identical to JOSEPH IANNI,  
who according to LA 4476-C-TE, recently was with NICK CIVELLA  
and AL MARSHALL re securing approval of a fifteen million  
dollar loan from Teamsters for purchase of Riviera Hotel in  
Las Vegas, Nevada.
