FROM LOS ANGELES 31

LA COSA NOSTRA, AR.

LA 4476-C-TE ADVISED THAT AL MARSHAL CALLED HIM FROM THE ESSEX HOUSE, NYC, ROOM 814, ON AUGUST 24 LAST ADVISING HE COULD NOT MAKE THE CONNECTION IN NYC AND WOULD NOW HAVE TO GO TO KC WITH JOE IANNI TO SEE NICK CIVELLA AS ORIGINALLY PLANNED. MARSHAL WILL BE STAYING AT THE CONTINENTAL HOTEL, KC, MO, THAT SAME NIGHT.

MARSHAL CALLED SOURCE ON AUGUST 25 LAST FROM KC, MO, ADVISING HE HAD SEEN CIVELLA AND THEY HAVE A TEAMSTER LOAN IF THE REPRESENTATION OF THE BUYERS FINANCIAL STATEMENT IS ANYWHERE CLOSE. MARSHAL AND IANNI WERE THEN PROCEEDING TO DALLAS AND THEN LA TO MEET WITH SOURCE ON AUGUST 27 LAST.

BOTH MET WITH SOURCE ON AUGUST 27 AND 28 LAST AND DISCUSSED TWENTY FIVE MILLION DOLLAR LOAN FROM THE CG
