THIS SHOULD BE DONE IN A MANNER CONSISTENT WITH FULL PROTECTION OF NY FOUR THREE THREE SIX DASH C DASH TE, ORIGINAL SOURCE.

ALSO ADVISE WHAT OTHER DISCREET INVESTIGATION YOU PLAN TO FURTHER DEVELOP THIS MATTER WHICH COULD HAVE IMPORTANT AND VIOLENT IMPLICATIONS. YOU SHOULD BE PARTICULARLY ALERT FOR ANY DEVELOPING ACTIVITY REGARDING PROCUREMENT AND/OR TRANSPORTATION OF WEAPONS WHICH COULD BE VIOLATION WITHIN FBI JURISDICTION.

AS ADDITIONAL DATA DEVELOPED ALSO ADVISE BUREAU WHAT RECOMMENDATIONS YOU HAVE FOR DISSEMINATION TO APPROPRIATE AUTHORITIES IN KEEPING WITH PROTECTION OF INFORMANTS AND BUREAU'S INVESTIGATIVE JURISDICTION. YOU SHOULD FAMILIARIZE NEWARK WITH
