MM 1231-C-TE advised on 10/28/67, that, with regard to the BONANNO family LCN situation, he has learned that, according to his sources, it has not improved, and is deteriorated to the point whereby informant does not see how a "war" can be averted. He asserts that BONANNO will not be deterred from controlling his family and will not back down. Informant advises that BONANNO at least has all the necessary weapons, ammunition and manpower needed to fulfill his ambition in this regard, or at least BONANNO feels certain of this.

Informant was asked how WILLIE DARA (LCN member of BONANNO family, residing Miami) feels about this and where he will stand in loyalty and advised that DARA, if pinpointed by his Regime, will ask to be put in inactive status, that he is "too old" for this nonsense.

Informant states that he learned from a source whose reliability is not certain and therefore cannot state the degree of veracity of the information, that the brother-in-law of TOMMY LUCHESE has stepped in and has taken over the LUCHESE family. Informant is not aware of the name of this individual.
