ON TEN, THIRTY ONE INSTANT, NY FOUR THREE THREE SIX-C-TE ADVISED THAT THE "COMMISSION" HAS GIVEN ITS OFFICAL APPROVAL TO THE ELEVATION OF PAUL SCIACCA AS "BOSS" OF THE DI GREGORIO (FORMERLY BONANNO) "FAMILY" AND FRANKIE "T" MARI HAS BEEN APPROVED AS "UNDERBOSS". NO FINAL DETERMINATIONS FOR THE OTHER POSITIONS OF LEADERSHIP HAVE YET BEEN MADE.

INVITATIONS REPORTEDLY HAVE BEEN GIVEN TO BOTH JOE AND BILL BONANNO TO RE-ENTER THE "FAMILY" AS "SOLDIERS". NO INFORMATION HAS BEEN FORTHCOMING AS TO HOW THESE DETERMINATIONS HAVE BEEN RECEIVED BY THE BONANNOS, HOWEVER, THE MAJORITY OF THE RANK AND FILE ARE EXPECTED TO TREAT WITH INDIFFERENCE THE BONANNOS' ACQUIESCENCE OR REJECTION OF THE "COMMISSION'S" DECISIONS.
