Cr 12/10/50, MM 722 advised unimentified employee of Washington Federal Savings & Loan Association reportedly delivered a number of such money orders to ROTHMAN on 12/7 - 8/60; and although employee's name not ascertained, Informant described employee as White male, 5' 7"-8", 165 lbs., dark or black hair, wears horn rim glasses, Jewish extraction, about 22-25 yrs of age. This individual reported close associate of SANTI ROTHMAN, son of NORMAN ROTHMAN and student at University of Miami.

Informant learned that ROTHMAN had furnished a number of such money orders to one MORRIS or MAURICE (INU), part owner of Rocking M. B. Lounge, Miami Beach nightclut, 2200 Park Avenue, Miami Beach. Informant learned this individual was taking these money orders to Puerto Rico weekend of 12/10/60, for cashing. MORRIS or MAURICE (INU) since identified as MAURICE STANLEY STREN, FBI #146278D, who with his brother WILLIAM STEEN formerly operated cheap bar in downtown Miami, but now are part owners of Rocking M. Lounge, Miami Beach.

Informant on 12/13/60, advised unidentified Savings and Loan Association employee drives 1955 Buick bearing 1960 Fla. License 1W-154075. On 12/14/60, this 1955 Buick Century 2-door Hardtop: Dark Gray with Cream on lower fenders and doors and Black Top located parked in front of Washington Federal Savings and Loan Association, 1113 Normandy Drive, Miari Beach. Above license issued to ABRAHAM HOFFMAN, 480 Northwest 122nd Street, North Miami, Fla.

On 12/15/60, Informant advised he had been unable to learn whether MAURICE or BILL STREN actually went to Fuerte Rice, or whether any of these money orders actually cashed as yet, locally or elsewhere.
