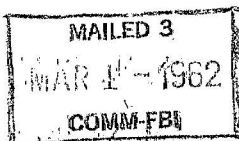

SAMUEL M. GIANCANA, AKA. AR. DAILY SUMMARY. RE PROPOSED MEETING OF HOODLUMS MIAMI BEACH, FLORIDA FEBRUARY, 1962. CG-6512-C-TE, WHO IS IN POSITION OF TRUST WITH CHICAGO HOODLUM ELEMENT, ADVISED FIORE "FI F" BUCCIERI IS A KILLER FOR CHICAGO SYNDICATE. IN ADDITION TO ALIAS "FI F" BUCCIERI ADDRESSED AS "NOSE" BY INTIMATES. INFORMANT OBTAINED THIS INFO FROM JOEY "D" DELMONICO. ALSO CONSIDERED POSSIBLE EXECUTIONER FOR THE MOB. MILWAUKEE INFORMANT REPORTED JULY, 1960 THAT BUCCIERI MAINTAINS FIREARMS RANGE IN LAKE GENEVA SUMMER HOME WHERE BUCCIERI AND ASSOCIATES TEST WEAPONS. INASMUCH AS CG 6486-C\* RECENTLY REPORTED PERSON IDENTIFIED AS "NOSE" USED AS AN EXECUTIONER FOR GIANCANA, PHOTO OF BUCCIERI BEING SENT MIAMI UNDER SEPARATE COVER TO ASSIST IN IDENTIFICATION AS INVOLVED IN CONTEMPLATED ESPOSITO CASE. FOR INFO MIAMI, 1962 ILLINOIS REGISTRATION 777-476 ISSUED TO ADOLPH LEWIN, 6157 NORTH SHERIDAN ROAD FOR 1962 FORD. 1962 ILLINOIS REGISTRATION 831-582, ISSUED TO MARIO PARTIPILO, 504 SOUTH WESLEY, OAK PARK ILLINOIS FOR 1962 CADILLAC SEDAN. GIANCANA ARMED AND DANGEROUS. (U)
