GIANCANA OBSERVED BY INFORMANT IN VICINITY OF ARMORY LOUNGE YESTERDAY. EVENING. CG SIX FOUR EIGHT SIX DASH ASTERISK REPORTED NO PRETINENT ACTIVITY FOR THAT DATE. PCI [REDACTED] ADVISED INSTANT THAT FRED MAGGIO, PINK CLOCK BAR, FOREST PARK, OPERATES LARGE SCALE BOOKING OPERATION, INCLUDING WAGERING ON HORSES, AND ALL SPORTING EVENTS. PAY OFF DAY FOR WAGERS IS MONDAY EVENING. INFORMANT UNABLE TO STATE AT THIS TIME THE METHOD UTILIZED BY THIS OPERATION FOR THE RECEIPT OF RESULTS. NOTED THAT PINK CLOCK FOR YEARS HAS BEEN CONSIDERED ONE OF GIANCANA-S BASES OF OPERATION, AND THE PLACE WHERE HE MAINTAINED A PRIVATE OFFICE ON THE SECOND FLOOR.
