NOTE NEW YORK TEL MARCH THIRTY ONE LAST REFLECTING TEETER-S INTERVIEW WITH WALTER WINCHELL, NY COLUMNIST, EXPOSING MCQUIRE DASH GIANCANA STORY, SANDY SMITH, CHICAGO TRIBUNE REPORTER PAREN PROTECT IDENT END PAREN, ADVISED THAT THE CHICAGO TRIBUNE HAS HAD FOR SOME TIME A STORY ON FILE REFLECTING THE RELATIONSHIP BETWEEN MCQUIRE AND GIANCANA, NAMED AS HIS SOURCES LAS VEGAS AUTHORITIES AND SUBSEQUENT FOLLOW UPS SHOWING THE TRAVELS OF GIANCANA AND MCQUIRE THROUGHOUT THE COUNTRY LAST SUMMER AND FALL. TRIBUNE THUS FAR HAS NOT RELEASED THE STORY, FEARING POSSIBLE LIBEL ACTIONS. (u)
