SAMUEL M. GIANCANA, AKA, AR. DAILY SUMMARY. 9-84

CG 6543 - PC ADVISED YESTERDAY THAT GIANCANA IS THE REAL AUTHORITY BEHIND THE WORLD WIDE DISTRIBUTORS, INC., CHICAGO, DISTRIBUTORS OF JUKE BOXES AND COIN OPERATED MACHINES. HE STATED THAT HE HAS DEFINITE KNOWLEDGE THAT WORLD WIDE HAS MANY SLOT MACHINES IN STORAGE, ALSO PIN BALL MACHINES AND OTHER GAMING DEVICES, IN A WAREHOUSE WHICH THE INFORMANT STATES HE CAN ASCERTAIN LOCATION. THE MACHINES ARE CRATED AND STAMPED AS JUKE BOXES, THEN SHIPPED TO ENGLAND AND PUERTO RICO. THIS BEING FOLLOWED CLOSELY TO ASCERTAIN IF ITAR VIOLATION CAN BE ESTABLISHED. INFORMANT ALSO STATES THAT GIANCANA IS THE ACTUAL POWER BEHIND EDDIE VOGEL IN THE CONTROL OF COIN MACHINES AND JUKE BOXES IN THE CHICAGO AREA. THIS FACT AND THE SITUATION WITH REGARD TO WORLD WIDE HAS BEEN BORNE OUT BY CG 6486-PC, WHO STATES THAT GIANCANA, IN DECEMBER LAST ORDERED VOGEL TO MAKE HIS JUKE BOX PURCHASES IN THE FUTURE FROM JOEL STERN AT WORLD WIDE.
