The majority of the conversation is between GLEASON and ACKALITIS; there is only one comment from FUREY. From the above it appears that ACKALITIS was referring to Congressman JOHN J. MURPHY and that he resented MERPHY's refusal to go along with his proposition.

TG: "They got another guy (inaudible) why don't you do something for him? We could use him."

AA: "I already spoke for him (inaudible). I spoke with MC GUIRE's man. How about DE COLA (ph) on the Island?"

AA: "He's got no work at all. In a month or two, yeh."

TG: (On the way out of NOONAN's office) "Check with me soon. I'll appreciate it."

In the outside office, ACKALITIS is heard to say "See you, AUSTIE" and AUSTIN FUREY replies "See you, ACK".

From the above it appears that GLEASON and ACKALITIS are placing men in employment with the Operating Engineers union, Local 15. It is noted that TOM MC GUIRE is the Business Manager of Local 15. NY is attempting to identify DE COLA.

Newark is requested to attempt to identify LOUIE LOMBARDI and to furnish any information available about a union charter either issued to CHARLIE "THE JEW" YANOWSKI or over which YANOWSKI had control. In addition, Newark is requested to supply any information reflecting that GYP DE CARLO, TEDDY GLEASON and ACKALITIS are collaborating in any ventures.

NY will contact NY 1716-C to determine whether an assessment from companies or employees is scheduled by Local 1730, ILA. NY will also attempt to identify charter allegedly given by LESTER CONNELL of the IBT.
