A confidential informant, who has furnished reliable information in the past, advised on April 3, 1959, that I. Irving Davidson, an individual who is registered with the United States Department of Justice as a foreign agent for the governments of Israel and Nicaragua, [contacted Avraham Salmon, Economic Counselor] (S) at the [Embassy of Israel, Washington, D. C., on the same date. Davidson brought to the attention of [Salmon] that there will be a number of Cubans and Nicaraguans in Washington, D. C., during the weekend of April 3, 1959, for the purpose of conferences at the Department of State and for "registration" in connection with an "anti-Castro" group coming to Washington, D. C., prior to a scheduled meeting of Cuban Premier Fidel Castro on the 17th or 18th of April. (X)

According to the informant, Davidson was to be visited by Riccy New, whom Davidson described as a top immigration lawyer who does work for Batista (Fulgencio Batista, former leader of Cuba). [Batista has requested that Mr. New see Davidson regarding a visit to Israel by Batista, which Davidson has made clear is not to be construed as an invitation from the Government of Israel. Davidson contemplated asking Mr. New if Batista is allowed to make such a visit and will look into the matter if a visa can be obtained for such a visit. (u)]

The Washington, D. C., telephone directory lists one Ricey S. New, Jr., as a lawyer in the Shoreham Building. (u)

It is noted that Castro is scheduled to depart Cuba for the United States on or about April 16, 1959. (u)

A confidential informant, who has furnished reliable information in the past, advised on April 3, 1959, that I. Irving Davidson, an individual who is registered with the United States Department of Justice as a foreign agent for the governments of Israel and Nicaragua, contacted Abraham Salmon, Economic Counselor at the Embassy of Israel, Washington, D. C., on the same date. Davidson brought to the attention of Salmon that there will be a number of Cubans and Nicaraguans in Washington, D. C., during the weekend of April 3, 1959, for the purpose of conferences at the Department of State and for "registration" in connection with an "anti-Castro" group coming to Washington, D. C., prior to a scheduled meeting of Cuban Premier Fidel Castro on the 17th or 18th of April. (X)(u)

According to the informant, Davidson was to be visited by Riccy New, whom Davidson described as a top immigration lawyer who does work for Batista (Fulgencio Batista, former leader of Cuba). Batista has requested that Mr. New see Davidson regarding a visit to Israel by Batista, which Davidson has made clear is not to be construed as an invitation from the Government of Israel. Davidson contemplated asking Mr. New if Batista is allowed to make such a visit and will look into the matter if a visa can be obtained for such a visit. (X)(u)
