The following investigation was conducted by  
SA WILLIAM R. JENKINS on 5-11-66:

## AT AMARILLO, TEXAS

A check of the Amarillo City and Telephone Directories failed to reveal the name of the above individual.

Operator 16, Amarillo Credit Association, 912 Taylor Street, advised their records contained no information whatsoever concerning this individual.

MR. [REDACTED] John Birch Society, [REDACTED] Avenue, an established source, advised he met this individual shortly after he moved to Amarillo a month or two ago. He advised that DIAZ LANZ is residing at 5213 West 15th Street in Amarillo with his wife and mother-in-law. MR. [REDACTED] advised that he does not know that DIAZ LANZ is employed regularly by the American Opinion Speakers Bureau but knows that he has made some speeches for them and also believes he has appeared before various Baptist groups in the Amarillo area. He advised that as far as he knows, this is the only employment of DIAZ LANZ.

Re Dallas letter to Oklahoma City 3-25-66 (inter-office).

For the information of the Bureau, U. S. Secret Service, Dallas, informed the Dallas Office captioned individual recently moved from Tulsa, Oklahoma to 5213 West 15th Street, Amarillo, Texas.

For the information of the Dallas Office, DIAZ has been the subject of considerable investigation by the Miami Office and in October, 1964, moved to Tulsa, Oklahoma, and became a full-time lecturer for the Christian Crusade. In January, 1965 Oklahoma City became Office of Origin in this case. Subject is the former chief of the Cuban Air Force, under CASTRO, who defected and who has previously been involved in militant anti-Castro activities.

On July 8, 1965, JULIAN WILLIAMS, Researcher, Christian Crusade, Tulsa, Oklahoma, advised SA DELMER R. EXON that DIAZ terminated his connection with the Crusade approximately one week previously. He said DIAZ planned to obtain
