There is attached for your information a copy of a letter, less enclosures, from the Director, Office of Munitions Control, dated October 22, 1968 and addressed to Mr. John H. Davitt, of this Division. You will note that this letter indicates that the Mexican Government has not yet advised whether it would make available certain witnesses. We have advised the Office of Munitions Control that these witnesses would be essential to a prosecution in this case.
