REGARDING THE CONVERSATION BETWEEN SUBJECT AND JOHN D'ARCO DECEMBER 12 LAST, GIANCANA ADVISED D'ARCO THAT HE EXPECTS TO BE OUT OF TOWN FOR A FEW DAYS, DATES NOT NAMED, BUT WILL BE BACK BEFORE CHRISTMAS. NEW YORK IS REQUESTED, THROUGH SOURCES CLOSE TO PHYLLIS MC GUIRE, TO BE ON THE ALERT FOR THE SUBJECT'S PRESENCE THAT AREA. D'ARCO AND GIANCANA DISCUSSED PLACING AN INDIVIDUAL IN A CIVIL SERVICE JOB IN WASHINGTON, HOWEVER, DID NOT NAME HIM. 
