PH 269-C advised on 12/20 and 21/61 that FRANK PALERMO is in Philadelphia and to his knowledge has not left the city. He said there has been no indication to him that JOHN JOSEPH VITALE, mentioned in referenced teletype has been in Philadelphia. (u)

From description at aircraft landing site in referenced teletype, it does not appear this would have been Philadelphia International Airport as only body of water close to Philadelphia International is the Delaware River, which is very seldom in the landing pattern due to the airport's site. (u)
