Enclosed for the Bureau is the original and four copies of a letterhead memorandum setting forth information received from WILLIAM CHASE, BLMR, Newark, N. J.

A copy of the LHM is being furnished to USA, Newark, N. J. under separate cover.

On 10/29/64, Mrs. JOHN E. EMMOTT, West Caldwell, N. J., advised she received a telephone call from NUNZIO PROVENZANO, Business Agent, Local 560, IBT, and a brother of subject, who asked her to have her husband contact him on an important matter as soon as possible.

On the same date JOHN E. EMMOTT stated he did not plan to call NUNZIO PROVENZANO and in fact intended to be unavailable to him. He stated he will maintain contact with the Newark Office.

As the Bureau is aware EMMOTT had a conversation with ANTHONY PROVENZANO and his attorney, (FNU) ZOLOTO on 9/23/64, as set forth in Newark report of 10/9/64.

For the information of WFO, AUSA RICHARD A. LEVIN, Newark, advised on 10/28/64, that the government's memorandum of opposition to the petition filed by PROVENZANO, had been filed at the Supreme Court on 10/26/64.

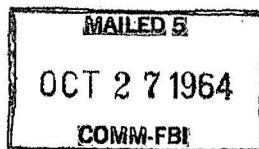

Re Newark radiogram, 10/16/64 entitled "GERARDO CATENA, AR", Bufile 92-3172.

On 10/21/64, WILLIAM CHASE, BLMR, Newark, confidentially advised as follows:

AL REGER, President, Local 522, IBT, Newark, has recently stated that he has seen a document, not further described that would prove that PROVENZANO was "framed" in this matter.

Another IBT source has advised CHASE that PROVENZANO is planning "something big" in his case, but that there is a chance that this might backfire and cause him more trouble. No definite information as to what PROVENZANO is planning was obtained.

CHASE stated that it is rumored that PROVENZANO has fired JAKE FRIEDLAND, counsel for Local 560 for many years for an unknown reason and that JOSEPH PECORA, an officer of Local 863, IBT, Newark, had had a personal conference with PROVENZANO before a regular meeting of Local 560 on 10/20/64. PECORA and PROVENZANO left the hall together after the meeting. It is not PECORA's normal practice to attend meetings of Local 560.(3) - Bureau
