Copies of these affidavits were furnished the Bureau by renKairtel.

It is noted that considerable investigation has been conducted by this Bureau concerning SILVERMAN and he is well known to the NYO and NK. AFFIDAVITS RE SILVERMAN ENCLOSED FOR NYO.

NK 2282-C is very close to SILVERMAN but has been unavailable up to this time.

AUSA LEVIN has also requested interview with PHILIP La DAMEO, President, Peoples Express, NK, NJ, who has also filed an affidavit, a copy of which has been furnished to you. It is noted that DAMEO is a close associate of PROVENZANO, and GERARDO CATENA, NJ Cosa Nostra commission member.

Attorneys and investigators for PROVENZANO will not be interviewed. Mr. LEVIN has indicated that he or USA DAVID MS SATZ, JR, will interview JACOB FRIEDLAND.

For the further information of the Bureau, discrepancies have been noted between the interviews with the affiants and the information contained in their affidavits.

UACB by 1/65, NY will interview MILTON SILVERMAN, and NK will interview DAMEO and the officials of Local 906, listed.
