Re: ALLEGED PLOT TO BRING ABOUT ENTRY INTO UNITED STATES OF FORMER CUBAN PRESIDENT FULGENCIO BATISTA

On December 7, 1959, MM T-1, who has furnished some reliable information in the past, and who has an acquaintance with a number of high officials of the former regime of FULGENCIO BATISTA of Cuba, furnished the following information:

MM T-1 referred to the fact that former Cuban President BATISTA is now living in exile in the Madeira Islands, Portugal.

On December 5, 1959, according to MM T-1, Miami Beach attorney LEONARD L. BURSTEN, office address 407 Lincoln Road, Miami Beach, and residence 4838 Pine Tree Drive, Miami Beach, contacted ALFRED MANHEIM, Miami, relative to a plan conceived and put into motion by BURSTEN for the purpose of bringing about the entry of FULGENCIO BATISTA into the United States from his island exile.

MM T-1 described BURSTEN as being a former United States Attorney at Milwaukee, Wisconsin, who has in his possession a certificate to that effect, who apparently has a very lucrative legal practice in Miami Beach. BURSTEN claims to represent some

On December 18, 1959, MM T-1 advised that HKRNANDEZ disclosed that on December 17th, he had received a cable from Mrs. BATISTA, stating that her ship would arrive at the Madeira Islands on December 21st, and that HKRNANDEZ should make certain as to what hotel in Paris the United States Congressmen would be in, so that GUELL in Madrid could meet them. HERNANDEZ expected to hear from GUELL on the evening of December 21st.

BURSTEN, according to MM T-1, advised that IRVING DAVIDSON was still in Miami, but that DAVIDSON was opposed to BATISTA's coming to the United States, because BATISTA has had connections with NORMAN ROTHMAN, Miami Beach gangster and hoodlum, who, according to DAVIDSON, once attempted to embarrass Vice President

On December 14th, examination of the outbound TWA manifests in possession of Immigration and Naturalization Service, New York City, reflected that ABRAHAM and BERTHA MULTER, 1397 East 21st Street, Brooklyn, Passport Numbers 218346 and 218721, respectively, departed New York City via TWA Flight 900, on November 25, 1959. The first foreign port for this flight was Lisbon, Portugal.

While being interviewed in another matter, on December 16, 1959, I. IRVING DAVIDSON, 1612 K. Street, N.W., Washington, D. C., advised Special Agents RICHARD B. KELLOGO and DONALD HOFFING he had learned while in Miami over the past weekend, that a plan is under way to get BATISTA into the United States, in spite of previous refusals by Immigration and Naturalization Service and the State Department to allow his entry. He said a group, whom he would not name, but some of whom he said are "no good", desired to present a proposition to BATISTA whereby they will get him into the United States for a price, by arranging for his testimony before a Congressional Committee or Committees.
