Will continue to follow and report the activity and associations of the subject.

ADMINISTRATIVE

The investigative period reflects investigation conducted prior to date of referenced report which was not available at time report was prepared. The delay in submission of a report was caused by SA PETER C. CLEMENTE's full time participation during April, 1966, in the DANIEL JESS GOLDMAN Kidnap case, Miami file 7-686.

Consideration in the past has been given to subject's informant potential. Interviews at that time disclosed his determination never to be an informant. In the immediate future SILESI will be contacted and probes made to determine if he is still unwilling to cooperate, with the FBI. However, it is felt he is a "die hard", "hard core", member of the La Cosa Nostra who will never become an informant.

An extra copy of instant report is being furnished New York for inclusion in 92-657 Sub 1, the CARLO GAMBINO "family" file of La Cosa Nostra.
