NY 6436-C-TE was contacted on 2/5/69 and furnished the following information concerning a large meeting of LCN members prior to the Apalachian meeting:

Approximately two months prior to the Apalachian meeting, there was a very large meeting of LCN members, including the Commission, at the estate of RICHIE BOIARDO in New Jersey. Informant attended this meeting.

Informant related that this gathering of LCN members at BOIARDO's estate was greater in attendance than the Apalachian meeting. Among the most prominent individuals in attendance were JOE BONANNO, SAM GIANCANA, VITO GENOVESE, CARLO GAMBINO, STEVE MAGADDINO, JOE IDA and JOE ZERRILI. These individuals comprised the representation of the Commission. The meeting began on one day at 12 Noon and continued through the night until 5 A.M. the next day. Informant advised that he drove to the meeting with several members of the GAMBINO group from Brooklyn. They drove to a big restaurant in Newark, New Jersey, which informant advised he believed was owned by JERRY CATENA. They parked their automobile in the parking lot of this restaurant where they were met by "made guys" from New Jersey who had their own automobiles. They got out of their car, as did others, and the Jersey "made guys" acted as chauffeurs and drove them to RICHIE BOIARDO's house two at a time.

The purpose of this meeting was to discuss the ANASTASIA killing. Informant advised the Commission members were "feeling the pulse" of the attendees. The Commission, of course, was aware ANASTASIA was slain but it appeared to the informant

It is pointed out to the Bureau that in January 1963, NY 3864-C-TE (deceased, member source) advised that the Apalachin meeting was a continuation of a meeting held earlier at RICHIE's farm (RICHARD BOIARDO) wherein an explanation was offered re the necessity for slaying ALBERT ANASTASIA. Some of the leaders present were identified as VITO GENOVESE, TOMMY LUCHESE, JOE RICCOBONO, JOE BIONDO, TOMMY RAVA and numerous others. Further, that the Apalachin meeting was subsequently set up to advise the national hoodlum groups inasmuch as only metropolitan LCN members attended the N.J. meeting.
