LA COSA NOSTRA - NEW YORK. AR - CONSPIRACY. OO NEW YORK.

SF THREE TWO ZERO EIGHT DASH C DASH TE CONTACTED FEB. TWO FOUR LAST AND ADVISED OF GARBAGE DUMP OPERATED BY GAMBINO FAMILY OF LCN LOCATED IN EASTCHESTER AND BOSTON POST ROAD AREA OF BRONX NEW YORK. THIS DUMP USED BY ALL FAMILIES OF LCN IN NEW YORK AREA TO DISPOSE OF BODIES OF MURDER VICTIMS. INFORMANT ADVISED BODIES CAN BE PICKED UP BY GARBAGE TRUCK OPERATED BY DUMP AND TAKEN TO DUMP, WHERE IT IS DEPOSITED BENEATH NORMAL REFUSE. BULLDOZERS ARE THEN USED TO PILE REFUSE OVER LOCATION WHERE BODY LEFT UNTIL IT IS LOADED ON BARGES FOR DISPOSAL IN SEA WITH REST OF GARBAGE.

THE INFORMANT ADVISED OF A MURDER OF A NEGRO IN NINETEEN SIXTYONE BY TONY VAAS (PHONETIC) AND "TAPPIE," TWO ITALIAN NARCOTICS DEALERS FROM BRONX AND BROOKLYN RESPECTIVELY. MURDER OCCURED BECAUSE NEGRO WAS SUSPECTED OF COOPERATING WITH NARCOTICS AGENTS.
