Recent information appearing in New York City newspaper indicates 14 alleged LCN members or associates were served with subpoenas, Miami, Florida, 2/28/69.

Kansas City advise, if known, the purpose of the trip for the 14 persons and also if CARL ANGELO DE LUNA is a LCN member.

NY 5042-C-TE (Member Source) on 3/6/69, advised SA WILLIAM J. CRUMLEY that KCO members of LCN visited Miami 2/28/69, according to TOM GRECO aka Tom Palmer, GENOVESE family Capo, because they want a mid-Western to be appointed to the Commission. Further they do not want TOMMY EBOLI to be appointed a Commission member as they feel there are enough NYC representatives already on the Commission and that the GENOVESE Commission spot should be allotted to the midwest.
