On Page 6 of referenced letter mention is made by SD 1064-C-TE to JAMES VINCENT TRIPODI aka Jimmy Tripod, as being a member of LCN and holding the position of capodecina in LA ROCCA family in Steubenville, Ohio. Further that he has a few soldiers under him.

The LCN National Summary Report of 9/26/68 of SA ROBERT G. O'NEIL at New York does not show any information regarding TRIPODI.

Cincinnati should immediately conduct investigation re TRIPODI and attempt to identify all LCN members from that area under him.

Also Cleveland in connection with the case entitled "WILLIAM J. KEES, ET AL; FRA; ITSP; MAIL FRAUD-CONSPIRACY" (CV file 29-1518, Bufile 29-49502) should issue instructions to all auxiliary offices to identify and attempt to prosecute all LCN members or LCN connected hoodlums who are in any way involved in the obtaining of bank loans by using phony notes of the Baptist Foundation of America. In the past SD 1064-C-TE has furnished extensive information re this organization and its promoters.
