On 3/4/69, PH 672-C-TE, a member source, was in company of Philadelphia Family member FRANK NARDUCCI, aka, and Capodecina JOHN ANTHONY CAPPELLO. On 3/5/69, source advised SA J. ROBERT PEARCE that CAPPELLO said he "had heard from the horse's mouth that 'CORCKY' from the Midwest was taking over VITO GENOVESE's place." "CORCKY" was not further identified. Where CAPPELLO heard this information was not learned. CAPPELLO did say that New York was the place to be a "capi" as New York was "where the power is, you receive more respect" as an LCN member and "you can earn more money there."
