The indices of the NYO contain no references identifiable with a MAX PESCH.

For the information of the Bureau, the name JAMES BELL, no further description, a reported policy operator in the Harlem sector of NYC for the Genovese LCN "Family" is not so referenced in the NYO indices.

The indices of the NYO contained gambling references for JAMES BELL, Sr., YOB 1892, Negro male, and his two sons -JAMES ABNER BELL, age 38 and JAMES BELL, Jr., age 50's. None of these individuals are known to be currently engaged in numbers or policy activity.

The NYO formerly carried VINCENT ROCCO PRISCO as a PCI (NY 137-10727) although allegedly not an LCN member, he has knowledge of SONNY FRANCESE, JAKE COLOMBO, FRANK RUSSO, JEMMY NAPP, BUSTER ALOI and BENNY WICKER.
