DR. ALEXANDER ROSENBERG, MIAMI BEACH, FLA., ADVISED THIS
DATE HE OPERATED ON CERONE FOR HEMORRHOIDS AT MT. SINAI
HOSPITAL, MIAMI BEACH, ON OCT. FOURTEEN, SIXTYTWO, AND HE WAS
DISCHARGED ON OCT. TWENTY, SIXTYTWO. HE SAW CERONE ON POST
OPERATIVE EXAMINATIONS TWICE A WEEK FOR THE FIRST MONTH,
THEREAFTER, AND ONCE A WEEK FOR THE SECOND MONTH THEREAFTER.
DR. ROSENBERG HAD NO RECORD OF ATTENDING CERONE SINCE THEN,
BUT STATED HE PROBABLY RECALLS HAVING SEEN HIM ONCE OR TWICE
IN THE LAST SEVEN YEARS, BUT MADE NO NOTATION OF SAME. HE
HEARD NO MORE FROM CERONE UNTIL ABOUT MARCH ONE, SIXTYNINE,
