LA COSA NOSTRA, AR-CONSPIRACY.

ON AUGUST FIFTEENTH, NINETEEN SIXTY EIGHT, SENIOR INVESTIGATOR MIKE LISMAN, NEW YORK STATE POLICE. FERNDAL, NEW YORK, ADVISED THAT TWO BODIES TENTATIVELY IDENTIFIED, FROM PERSONAL POSSESSIONS, AS FRANK TUMINARO, FEDERAL BUREAU OF INVESTIGATION NUMBER TWO FOUR THREE SIX FIVE EIGHT C, AND FRANK JOSEPH ~~GANGI~~ ^EGANGI, FEDERAL BUREAU OF INVESTIGATION NUMBER SEVEN ONE SEVEN EIGHT TWO SIX A, WERE LOCATED IN A WOODED SECTION OFF ROOSA GAP ROAD, NORTH OF BLOOMINGBURG, NEW YORK, AT APPROXIMATELY TEN COLON THIRTY AM, THAT DATE, BY PASSERBY ATTRACTED BY THE SMELL. BOTH BODIES PARTIALLY WRAPPED IN PLASTIC BAGS AND BOUND WITH ROPE. AUTOPSIS SHOWED EACH WAS
