PH 599-C-TE, a member of the Philadelphia Family of LCN, continues to furnish information relative to LCN on a limited basis.

PH 521-C-TE, who is not a member of LCN but is a son of an LCN member, continues to furnish information related to LCN membership in the Upstate Pennsylvania Anthracite area.

PH 872-C-TE, who is not a member of LCN, is also the son of an LCN member in the Upstate Pennsylvania Anthracite area. He has furnished considerable information of high quality relative to illegal activity and LCN membershippin the Upstate Pennsylvania area.
