SAMUEL M. GIANCANA, AKA, AR. DAILY SUMMARY. CG 6443 RECENTLY PROVIDED INFORMATION TO THE EFFECT THAT THE LATE WILLIAM "ACTION" JACKSON, WHO WAS FOUND KILLED IN GANGLAND STYLE AUGUST 11 LAST, HAD BEEN ASSOCIATED WITH SAM LOUIS IN THE OPERATION OF THE PARR LOAN COMPANY, OAK PARK, WHO IN TURN, ACCORDING TO THE INFORMANT, IS A PARTNER OF GIANCANA. INFORMANT ADVISED IN ADDITION THAT THE BUILDING IN WHICH THIS LOAN COMPANY IS LOCATED IS OWNED BY CHICAGO PD CAPTAIN LOUIS CAPPARELLI, WHO HAS BEEN DESCRIBED IN PAST AS AN ASSOCIATE OF CHICAGO HOODLUMS. ANONYMOUS SOURCES AND OTHER INFORMANTS, SPECULATING ON JACKSON'S DEMISE, HAVE STATED THAT JACKSON WAS IN TROUBLE IN THE JUICE RACKET AND WAS KILLED BY SAM DESTAFANO, ALSO, THAT HE RAN A POKER GAME IN CICERO FOR THE OUTFIT AND WAS KILLED IN RETALIATION OF REFUSING TO SHUT DOWN. NOTED THAT CICERO HAS BEEN A TARGET OF CHIEF INVESTIGATOR OF THE STATES ATTORNEY, ROSWELL SPENCER, (FORMER SA), AND AS RESULT, CERTAIN OPERATIONS IN CICERO HAVE BEEN ORDERED SHUT DOWN UNTIL HEAT COOLS. CG 6486-C* REPORTED NO PERTINENT ACTIVITY THIS WEEK TO DATE. NOTED THAT GIANCANA HAS BEEN IDENTIFIED AS BEING POSITIVELY WITH PHYLLIS MC GUIRE IN NEW JERSEY. DOMINIC BLASI, GIANCANA CHAUFFEUR AND BODY GUARD, HAS NOT BEEN OBSERVED IN CHICAGO, INDICATING POSSIBILITY HE IS EITHER WITH GIANCANA OR IS OUT OF TOWN FOR SOME OTHER REASON. SITUATION INVOLVING PARR LOAN COMPANY IS BEING EXPLORED. ARMED AND DANGEROUS.
