CG SIX FIVE SIX FOUR DASH PC ADVISED THAT ANTHONY RICCI, OF MIAMI, IS IN CHICAGO AND WAS IN CONTACT WITH ANTHONY ACCARDO IN CHICAGO ON SEPTEMBER FIVE LAST. CG SIX TWO FOUR ONE DASH C ADVISED SEPTEMBER SIX LAST THAT HE OBSERVED ACCARDO IN COMPANY WITH RICCI AT THE SAHARA INN MOTEL, SCHILLER PARK, ILL., SEPTEMBER FIVE LAST. INFORMANT STATED THAT RICCI IS REGISTERED UNDER HIS TRUE NAME AT THIS MOTEL. NOTED THAT SAHARA INN IS ALLEGED GIANCANA ENTERPRISE. NOTED THAT AT THIS POINT NOT POSSIBLE TO CHECK WITH MOTEL TO ESTABLISH RICCI-S PRESENCE OFFICIALLY. (u)

CHICAGO PD SOURCE ADVISED THAT A SOURCE OF HIS HAS STATED THAT ACCARDO IS CHARTERING A PLANE FOR WEEKEND OF SEPTEMBER EIGHT NEXT TO TAKE SOME FRIENDS OF HIS TO LAS VEGAS FOR WEEKEND. NOTED THAT ACCARDO MUST BE BACK NEXT WEEK FOR HIS TAX TRIAL. EFFORTS THUS FAR TO VERIFY FLIGHT FROM CHICAGO NEGATIVE. LAS VEGAS IS REQUESTED TO BE ON ALERT FOR APPEARANCE OF ACCARDO GROUP. (u)
