SAMUEL M. GIANCANA, AKA., AR. DAILY SUMMARY.

CG 6575-C TE ADVISED INSTANT HE WAS IN CONTACT WITH JULIAN PORTMAN, PLAZA RECORDS, LOS ANGELES, CALIFORNIA, TELEPHONICALLY OCTOBER 17 LAST. NOTE PORTMAN AND PLAZA RECORDS HANDLING SINGER OF INFORMANT THROUGH SAM AND CHARLES ENGLISH, GIANCANA LIEUTENANTS. INFORMANT PASSED ON INSTRUCTIONS FROM ENGLISH TO BE IN CHICAGO OCTOBER 19 NEXT FOR CONFERENCE REGARDING SINGING CONTRACTS AND RECORDS. PORTMAN EXPLAINED HE COULD NOT BE IN CHICAGO AS ORDERED, BECAUSE "CHUCKIE'S (ENGLISH) BOSS IS IN TOWN." PORTMAN SAID ALSO IN PROCESS OF CONSUMMATING ACAPULCO DEAL, WHICH, ACCORDING TO INFORMANT, NOW APPEARS TO BE IN PART, A NIGHTCLUB, WHICH OPENS SHORTLY, AND IS APPARENTLY PARTIALLY UNDER CONTROL OF GIANCANA. (u)

INFORMANT STATES PORTMAN PASSED ON A MESSAGE TO HIM TO CONTACT ONE LIEUTENANT HAIG, INDIANAPOLIS POLICE DEPARTMENT, AND HAVE HAIG MAKE CONTACT WITH CAPTAIN VISA, SANTA BARBARA, CALIFORNIA, POLICE DEPARTMENT, TO LESSEN HEAT PLACED BY VISA UPON ONE RICK VALNY, OPERATOR OF KINGS SUPPER CLUB, SANTA BARBARA, CALIFORNIA. APPARENTLY VALNY MOVING INTO THAT PARTICULAR SUBURBAN AREA, AND VISA IS ATTEMPTING TO PUSH HIM OUT. VISA, ACCORDING TO PORTMAN, WAS FORMERLY WITH INDIANAPOLIS POLICE DEPARTMENT. (u)
