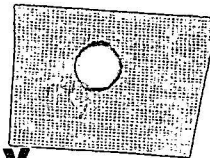
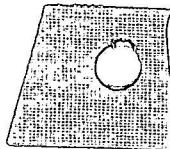

SAMUEL M. GIANCANA, AKA., AR. DAILY SUMMARY.

CG 6486-C\* ADVISED EARLY AM OCTOBER 30, LAST, GIANCANA AND GROUP, INCLUDING INDIVIDUAL ASSOCIATED WITH SPORTSMAN'S PARK RACE TRACK, POSSIBLY WILLIAM JOHNSTON, DOMINIC BLASI, BERNARD GLICKMAN, ANTHONY ACCARDO, DISCUSSED GENERAL MATTERS RELATING TO THE ENTERTAINMENT BUSINESS, MUCH OF WHICH INCLUDED VILLA VENICE SUPPER CLUB, A GIANCANA ENTERPRISE. GIANCANA ADVISED THAT VILLA VENICE WILL DEFINITELY BE A GOING PROPOSITION, AND WAS ADVISED BY LEO OLSEN, OWNER OF RECORD, THAT RESERVATIONS HAVE BEEN MADE IN ADVANCE FOR AT LEAST THREE MONTHS. OTHER TOPICS OF CONVERSATION INCLUDED CUBAN CRISIS, AND FACT THAT KENNEDY IS UTILIZING SITUATION AS POLITICAL FOOTBALL, TO HIS OWN ADVANTAGE. (u)

CG 6241-C ADVISED INSTANT THAT GIANCANA AND MOST OF HIS ASSOCIATES HELD MEETING EARLY AM INSTANT AT SAHARA INN NORTH, MOTEL, PURPOSE OF WHICH UNKNOWN. INFORMANT STATES GIANCANA HAD BEEN AT VILLA VENICE EARLIER LAST EVENING. CG 6486-C\* ADVISED INSTANT THAT GIANCANA ALSO PRESENT FOR SHORT TIME AT VICINITY OF SOURCE. (u)
