SAMUEL GIANCANA, AKA, AR.

NY 3508-PC ADVISED THIS DATE THAT IN CONVERSATION WITH LENNY GAINES, A WRITER FOR SINGER EDDIE FISHER, GAINES ADVISED HIM THAT GAINES, FRANK SINATRA, FISHER AND SUBJECT RECENTLY FLEW FROM LOS ANGELES TO RENO EN ROUTE TO LAKE TAHOE, NEVADA, IN SINATRA'S PRIVATE PLANE. GIANCANA WAS PRESENTED TO GAINES AS SAM MOONEY AND GAINES WAS FURTHER ADVISED THAT MOONEY WAS "THE DOCTOR." DURING THIS FLIGHT SINATRA AND GIANCANA SAT TOGETHER AND CONVERSED PRIVATELY, EXCLUDING THE REST OF THE GROUP. (U)

FISHER WAS TO APPEAR AT DESERT INN COMMENCING NOVEMBER 5 LAST FOR AN ENGAGEMENT PAYING \$100,000 PER WEEK. APPROXIMATELY TWO WEEKS AGO, FRANK SINATRA TELEPHONICALLY CONTACTED FISHER AND ADVISED HIM THAT HE HAD "DONE FISHER A BIG FAVOR," IN THAT SINATRA HAD CANCELLED HIS DESERT INN APPEARANCE AND ARRANGED FOR HIM TO APPEAR IN A CHICAGO NIGHTCLUB, COMMENCING NOVEMBER 8 INSTANT, AT \$15,000 A WEEK. GAINES INDICATED THAT THIS ARRANGEMENT WAS MADE AT THE REQUEST OF GIANCANA AND THAT FISHER IS EXTREMELY UPSET, BUT IS FULFILLING ENGAGEMENT. (U)
