CG 6576-C\* REPORTED NOVEMBER 20 LAST THAT ANTHONY CHAMPAGNE, LAWYER FOR GIANCANA AND ROCCO POTENZO, GIANCANA LIEUTENANT, HELD CONFERENCE WITH PAT MARCI AND JOHN D'ARCO, FIRST WARD REPRESENTATIVES, DISCUSSED FACT THAT D'ARCO AND MARCI WERE INSTRUMENTAL IN PUTTING IN FIX WITH POLICE AND LOCAL COURT RE RECENT GAMBLING RAID CONDUCTED BY CHICAGO POLICE DEPT ON RIVIERA LOUNGE, NILES, ILL. CASE WAS DISCHARGED YESTERDAY IN LOCAL COURT. D'ARCO TOLD CHAMPAGNE TO BE SURE TO "TELL MOE WHO DID THIS FOR HIM." (u)

NOTE CONTACT MADE NOVEMBER 19 LAST WITH CG 6564-PC, REGARDING GIANCANA ET AL. THIS INFORMANT ENTERED VICINITY OF CG 6486-C\* NOVEMBER 20 LAST INQUIRED AS TO WHEREABOUTS OF GIANCANA, WAS TOLD HE IS OUT OF TOWN, WILL BE BACK NOVEMBER 21 NEXT. CG 6486-C\* REPORTED NOVEMBER 20 THAT FRANK FERRARO, GUS ALEX AND HY GODFREY HELD DINNER CONFERENCE THAT DATE, MOST OF CONVERSATION WAS OF DESULTORY NATURE, ALEX RELATED DETAILS CONCERNING TRIP TO WEST GERMANY. MADE ARRANGEMENTS TO MEET AT UNSPECIFIED LOCATION NOVEMBER 21, POSSIBLY WITH GIANCANA. (u)

EARLIER GODFREY MADE CONTACT AT SOURCE WITH BUTCH BLASIE AND ASKED FOR GIANCANA, WAS ADVISED GIANCANA EXPECTED BACK IN CHICAGO ABOUT 7 AM NOV 21 NEXT. CHARLES ENGLISH THEN ENTERED, MADE CONTACT WITH BLASI, MADE ARRANGEMENTS TO MEET WITH UNKNOWN IN AUTOMOBILE NEAR SOURCE. ARMED AND DANGEROUS. (u)
