SAMUEL M. GIANCANA, AKA., AR. DAILY SUMMARY.

CG 6564-PC ADVISED INSTANT OF FOLLOWING: INSISTS THAT GIANCANA'S HEADQUARTERS CONTINUES TO BE THE ARMORY LOUNGE, STATES HE WAS IN CONTACT THERE WITH GIANCANA APPROXIMATELY TWO WEEKS AGO. STATES GIANCANA CONSIDERED THE MOST POWERFUL MOBSTER IN THE COUNTRY TODAY, AND THAT THE CHICAGO CRIMINAL ORGANIZATION IS MORE DEEPLY ENTRENCHED THAN EVER, DUE TO THE FACT THAT CURRENT INVESTIGATIONS BY LAW ENFORCEMENT GROUPS HAS CAUSED THE ORGANIZATION TO BE PLACED ON A "SINK OR SWIM" BASIS. ALL MEMBERS FOLLOW GIANCANA WITHOUT QUESTION. STATES THERE ARE MEMBERS OF THIS ORGANIZATION WHOSE IDENTITIES ARE KNOWN ONLY TO GIANCANA. NAMED SOME OF GIANCANA'S CHIEF UNDERLINGS, GENERALLY UNKNOWN TO PUBLIC, AS FIORE BUCCIERI AND CHARLES ENGLISH, BOTH CHICAGO TOP HOODLUMS. RE VILLA VENICE, STATES GIANCANA UTILIZING THIS ESTABLISHMENT AS QUICK WRITE OFF, WILL UNLOAD IT SHORTLY AFTER THE FIRST OF THE YEAR, AFTER SINATRA, ET AL, HAVE PLAYED THEIR ENGAGEMENTS.
