HOODLUMS TO BE KILLED. SOURCE OF INFORMATION NOT REVEALED  
AS COMING FROM CHICAGO. WIELT STATES NEAL SUMMERS WELL  
KNOWN TO HIM BUT WAS NOT AT FUNERAL VIRGIL AND HAS NOT BEEN  
AROUND MT. VERNON SEVERAL YEARS AND WHEREABOUTS UNKNOWN. (u) M
