## ADMINISTRATIVE

Information received from informants and through surveillance indicates subject continues to spend a considerable amount of his spare time working in the yard at his residence. It is noted that one informant residing across the street from the subject states that on the week end he can observe the subject working in the yard a majority of the time.
