Indianapolis, Indiana. He informed MORRIS E. MITCHELL is the nephew of ISAAC MITCHELL, aka "TUFFY" MITCHELL. He advised that, while he cannot prove it, it is generally known that MORRIS E. MITCHELL has been financed by his uncle, "TUFFY" MITCHELL. He stated "TUFFY" MITCHELL has been operating the "numbers" racket for years in Indianapolis, Indiana, and is reported to have started operation in the same racket in Akron, Ohio. U

On September 14, 1959, CG T-23, a Miami bail bondsman, advised that he had received no information indicating that a bonding enterprise by the name of the Trans-American Surety Company is operating in Miami and stated that he has received no information that anyone named MOSES MASSAU (Ph), is operating as a bail bondsman in Miami. U

On September 14, 1959, BRUCE KENNEDY, Office of Insurance Commissioner, State of Florida, Miami Office, advised that his files reflect no record of a license having been granted to the Trans-American Surety Company to operate in the Miami area. He stated that MOSES MASSAU (Ph) was unknown to him as a bail bondsman. U

The following investigation was conducted by  
SA PAUL A. CAJIGAS at Miami, Florida: U

On April 22, 1958, Mr. JAMES HERRIN, manager of the Credit Bureau of Greater Miami, 160 N. E. Fourth Street, Miami, Florida, confidentially exhibited "Special Service Character Credit Report" dated March 13, 1958, for LOUIS PETER BRADY, 2301 North Bay Road, Miami Beach, Florida. The report reads as follows: U

#### "IDENTITY

"Subject is known at Miami as "Lou" Brady and was born 2/25/19. During interview he said he was not Italian, but his wife told a former landlord subject is Italian. He has typical Italian build and looks. He is short, heavy, has black hair, and neat appearance. He speaks English well and was very courteous, but would not give any information other than saying he was not
