CG SIX FOUR FIVE SEVEN DASH PC ADVISED THAT DOMINIC BLASI, GIANCANA/S  
CHAUFFEUR AND BODYGUARD IS NOW DRIVING A NEW VALIANT, LICENSE NUMBER  
GV SIX NINE NINE ZERO. PCI ADVISED THIS VEHICLE SEEN AT ARMORY  
LOUNGE AS OF THIS DATE, BEING DRIVEN BY BLASI. CAR IS REGISTERED TO  
MARIO DE MARIA, OAK PARK, ILL. CG SIX FOUR FIVE SEVEN PC ALSO ADVISED  
THAT GIANCANA HAS GOTTEN RID OF HIS APARTMENT OVER THE PINK CLOCK  
RECENTLY, AND APPEARS TO BE ATTEMPTING TO DISPOSE OF CHICAGO TRACES.
