PCI [ ] ADVISED THIS DATE THAT SHE OBSERVED DOMINICK QUOTE OTHER 4  
BUTCH END QUOTE BLASI, GIANCANA LIEUTENANT, AT ARMORY LOUNGE, ENTERED  
THIS ESTABLISHMENT CARRYING LARGE BRIEFCASE. ARRIVED IN NINETEEN FIFTY  
NINE FORD GALAXIE, ILL. LICENSE GW SEVEN EIGHT NINE SIX. BLASI WAS  
UNACCOMPANIED, INDICATING GIANCANA IS NOT IN TOWN. NUMEROUS OTHER  
INDIVIDUALS ARRIVED AT ARMORY, SINGLY AND IN PAIRS, THESE PERSONS  
STAY AT ARMORY WAS OF SHORT DURATION, INDICATING PROBABILITY THAT  
BLASI WAS ISSUING INSTRUCTIONS IN GIANCANA/S ABSENCE. IT HAS BEEN  
NOTED PREVIOUSLY THAT WEDNESDAY APPEARS TO BE MEETING NIGHT AT THE  
ARMORY LOUNGE, USUALLY ATTENDED BY GIANCANA WHEN IN TOWN, OTHERWISE
