CG SIX FOUR FOUR THREE DASH C ADVISED THAT LESTER KRUSE, IDENTIFIED BY INFORMANT AS QUOTE GENERAL END QUOTE IN GIANCANA/S ARMY, IS LEAVING CHICAGO FOR AN EXTENDED PERIOD OF TIME, DESTINATION UNKNOWN, ALTHOUGH BELIEVED BY THE INFORMANT HE INTENDED TO TRAVEL TO LAS VEGAS. GUS LIEBE, PARTNER OF LESTER KRUSE IN J AND J GAMBLING OPERATION, WILL COUNTRY, ILL. ADVISED INFORMANT RECENTLY THAT SOME OF QUOTE "THE BOYS" END QUOTE PLAN ON SPENDING SOME TIME AT THE FISHING RESORT OF RALPH CAPONE IN MERCER, WISCONSIN, AND OTHERS ARE KNOWN TO BE IN GRAND HAVEN, MICHIGAN. INFORMANT STATES THAT KRUSE IS QUOTE MEMBER OF THE BOARD OF DIRECTORS END QUOTE OF GIANCANA ORGANIZATION AND AS SUCH GIVES DIRECT ORDERS TO ROCCO POTENZO, DESCRIBED BY INFORMANT AS QUOTE GIANCANA LIEUTENANT END QUOTE, AND MAKES FREQUENT VISITS TO POTENZO/S HOME IN SKOKIE, ILL. DETROIT AND MIAMI ARE BEING ALERTED AS TO POSSIBILITY
