SAMUEL M. GIANCANA, AKA, AR. RE MYAIRTEL TO BUREAU JULY 27, 1961. PCI [REDACTED] CHAUFFEUR FOR MC GUIRE SISTERS, ADVISED PHYLLIS REQUESTED HIM TO DRIVE HER TO OWINGS MILLS, MARYLAND, ON AUGUST 2, 1961. MC GUIRE WILL STAY IN A MOTEL. SHE WILL TRAVEL IN HER 1961 WHITE CADILLAC CONVERTIBLE WITH BLACK TOP, NEVADA LICENSE NUMBER C-63414. PCI DOES NOT KNOW PURPOSE OF HER TRIP OR LENGTH OF PROPOSED VISIT BUT OF OPINION SHE WILL RETURN TO NYC BEFORE SHE TRAVELS TO VALLEY FORGE, PENNSYLVANIA, ON SUNDAY NEXT. MC GUIRE HAS ONE WEEK ENGAGEMENT AT A SHAKESPEARE OPEN AIR THEATRE AT VALLEY FORGE. PCI SAID HE WILL OBTAIN NAME OF MOTEL WHERE SHE WILL STAY IN OWINGS MILLS. HE EXPECTS TO DEPART NYC ABOUT 5 PM AND ARRIVE OWINGS MILLS 5 HOURS LATER. NYO DOES NOT PLAN ANY SURVEILLANCE TO OWINGS MILLS. BALTIMORE REQUESTED TO CONSIDER MICROPHONE SURVEILLANCE COVERAGE AT MOTEL WHEN NAME IS OBTAINED. PCI IN DAILY CONTACT WITH MC GUIRE SINCE JULY 24, 1961 BUT HAS NOT SEEN SUBJECT. DOES NOT THINK SUBJECT IN NYC AT PRESENT. MC GUIRE ASKED PCI IF HER TRUNK WAS BIG ENOUGH TO TAKE A LOT OF "THINGS" TO OWINGS MILLS BUT DID NOT SPECIFY. FOR INFO BALTIMORE MC GUIRE IS GIRL FRIEND OF SUBJECT WHO MAY MEET MC GUIRE IN OWINGS MILLS. SUBJECT IS A TOP HOODLUM OF CGO AND CURRENTLY UNDER INTENSIFIED INVESTIGATION. CHICAGO WILL ADVISE BALTIMORE IF SUBJECT CURRENTLY IN CHICAGO AND IF HE DEPARTS AUGUST 2 NEXT. PHILADELPHIA WILL ALSO CONSIDER MICROPHONE SURVEILLANCE COVERAGE WHEN NOTIFIED WHERE MC GUIRE WILL STAY IN VALLEY FORGE. COPY MAILED TO NEWARK AND PHILADELPHIA. SUBJECT SHOULD BE CONSIDERED ARMED AND DANGEROUS. u
