SAMUEL M. GIANCANA, AKA, AR. DAILY SUMMARY. CG 6443-C ADVISED YESTERDAY THAT LESTER KRUSE'S STATUS WITH THE GIANCANA ORGANIZATION IS SUCH THAT HE IS DEFINITELY OVER RALPH PIERCE AND ROCCO POTENZO. IN THIS CAPACITY, IS OVERLORD OF LUCRATIVE GAMBLING OPERATION AT J AND J PICNIC GROVE, WILL COUNTY, ILLINOIS. OPERATION IS RUN PRIMARILY FOR GIANCANA AND GUS ALEX, AND HAS 7 INVESTORS WHO KEEP BANK AT THIS OPERATION AT THE QUARTER OF A MILLION DOLLAR LEVEL AT ALL TIMES. OPERATION IS NOW RUN ON SNEAK BASIS IN VIEW OF LOCAL HEAR. HOWEVER, CONTINUES TO BE A LUCRATIVE SOURCE OF INCOME.
