ANTHONY PROVENZANO is President of Local 560, International Brotherhood of Teamsters. He was recently convicted in United States District Court, Newark, New Jersey, for extortion and is presently awaiting to be sentenced.

APPEALING THE CONSTRUCTION.

NK T-6 advised during June, 1963, that PROVENZANO supposedly owns the tavern at 376 Duncan Avenue, Jersey City, New Jersey. Informant stated that prior to PROVENZANO's trial he visited this tavern two or three times a week and conferred with FAUGNO, ROMEO, and BILLY MACK and they often would leave together in PROVENZANO's Cadillac. NK T-6 further advised that FAUGNO was being financed by PROVENZANO and the Teamsters Union in his shylock operation.

NK T-6 advised that FAUGNO is operating with the complete protection from the Jersey City, New Jersey Police Department, and that he maintains an office in a small room adjoining the bar. NK T-6 stated that FAUGNO maintains two guns in his desk drawer and usually carries a small gun in a shoulder holster. NK T-6 said that number runners frequenting the tavern at 376 Duncan Avenue turn in their action which is placed behind a large hinged board that is used as a coat rack.
