NY T-4 stated that it appeared that the President of Local 147 and the head of the Master Platers Association had gotten together and approached JOHNNY O'ROURKE, President, Teamsters Joint Council 16, and asked O'ROURKE to intercede against LUCIANO and O'ROURKE declined to do so. NY T-4 stated it was his opinion that O'ROURKE then contacted JIMMY HOFFA and, according to NY T-4, CARL LUCIANO received a telephone call from the office of JIMMY HOFFA in Washington, D. C. and was told to lay off of the Master Platers Association. NY T-4 stated that LUCIANO told him he had personally contacted HOFFA and was told by HOFFA to lay off of the Master Platers Association.

NY T-4 advised in February, 1962, he had no additional information regarding the Master Platers Association, and the attempted shakedown by CARL LUCIANO, Local 875, IBT, of that association. NY T-4 stated he had heard that LUCIANO had been very ill with pleurisy or pneumonia during part of January and February, of 1962.

NY T-5 advised in January, 1962, that he had heard that CARL LUCIANO, Local 875, IBT, was attempting to organize the Master Platers Association and while in Washington, D. C., JOHN O'ROURKE, President, Joint Council 16, IBT, asked JAMES RIDDLE HOFFA, President, IBT, to order LUCIANO to cease his attempts regarding this matter. NY T-5 stated he heard that HOFFA then had LUCIANO contacted and told him to stop this organizing attempt. NY T-5 stated he heard that LUCIANO then contacted HOFFA and was again told to stop his organizing attempts. NY T-5 stated he heard that LUCIANO and JERRY MANCUSO, acting secretary of Local 875, IBT, then spread a story that another individual was receiving a payoff from the Master Platers Association in order to keep them out. NY T-5 advised that LUCIANO and MANCUSO subsequently denied making any statement concerning another individual taking a payoff and the matter was dropped. NY T-5 indicated that he heard that O'ROURKE was openly encouraging LUCIANO but stopped LUCIANO's activity by behind the scene activity on O'ROURKE's part.
