A review of ROTONDO's files (Bufiles 92-9917 and 165-3031) in Miami Office disclose that only information regarding ROTONDO's status as an LCN member came from NY 3461-C-TE, who stated on 9/13/65, that ROTONDO is definitely not a member of LCN and NY 1839-C-TE, who stated on 10/17/67, that ROTONDO is a "made guy" in the Vito Genovese Family.

In view of these conflicting opinions and that no recent information has been received regarding ROTONDO'S LCN membership, the New York Office is requested to re-contact above informants, as well as other informants knowledgeable of members of the Genovese Family regarding ROTONDO's status as an LCN member.

After receipt of above information from New York and if determined ROTONDO is an LCN member, a membership index card will be submitted to Bureau as requested in referenced letter.

MM 1401-C-TE advised ROTONDO spent about a month in New York returning to Miami on 6/28/71, stayed for one day to pick up some money for SALERNO and drove back to New York with NORMAN ROTHMAN. ROTONDO will be with TONY SALERNO in New York.

New York is also requested to attempt to establish ROTONDO's presence in New York through known contacts of ROTONDO and SALERNO.
