AT NEW ORLEANS, LOUISIANA. 1) Will verify birth of FRANK CARACCI on 10/12/29.

2) Will report appellate court decision on CARACCI's U. S. District Court conviction for bribing an IRS Agent.

3) Will conduct surveillance of CARACCI to determine his current activities and to determine if he still maintains personal contact with CHARLIE PACE of Palace Amusement Company.

4) Will interview NICK KARNO and FRANKIE FORD to determine their current financial interest in the 500 Club and the 500 Backstage Bar.

ADMINISTRATIVE:

On 12/14/70, NO 1899-PC advised SA TERRY D. PETERS that he had seen FRANK CARACCI at the racetracks on 12/12/70standing at the bar, east end of the grandstand where the horses come onto the track. Informant stated that CARACCI has been seen at the track on an almost daily basis.

On 12/9/70, NO 1075-C advised SA L. M. SHEARER, JR. that CHARLIE PACE was quite upset by the FBI raid in November, 1970, but not because stolen property was found. Informant stated that PACE was upset because of something that will get him into trouble with his associates for the loss of the machines and the money. An employee mentioned that it was something done behind FRANK's (CARACCI) back. Informant believes that PACE fears that FederalAAgents will find out that he is shylocking, charging as much as 60 per cent interest on loans and no record is kept once the loan is paid off.

NO 1075-C advised that many banksloans are made to customers of Palace Amusement which are co-signed by PACE and CARACCI; however, some of their customers could not get bank

loans and these must pay the high interest if they want money. Some of these high interest loans are made through Rex's Finance Company; however, if inquiry is made concerning the loan after it is paid, no record can be found and the company will not acknowledge that such a loan existed.

On 3/18/71, NO 1203-C advised SA WILLIAM F. KUSCH that SIDNEY (LNU), who may be identical to SIDNEY LAZARD, acts as a go-between for FRANK CARACCI and the sport bookee. CARACCI needs a go-between because he bets on winners so often that many bookees are afraid to take his action. Informant stated that SIDNEY takes CARACCI's action, some of which he books himself, and some of which he lays off to T. J. TILLMAN, with whom CARACCI cannot get done with.

New Orleans indices reflect that SIDNEY LAZARD is a prominent New Orleans attorney and is known to be a degenerate bettor. T. J. TILLMAN is the subject of New Orleans file 165-1477.
