CG 6498-PC ADVISED THIS DATE THAT PURPOSE OF HIS CONFERENCE TWO WEEKS AGO WITH TONY TISCI AS REPORTED BY CG 6576-C*WAS TO INFORM TISCI THAT DECISION MUST BE MADE NOW AS TO WHETHER INFORMANT WILL RUN FOR REELECTION AS DEMOCRATIC WARD COMMITTEEMAN OF THE TWENTY-EIGHTH WARD, OR WHETHER SOME ONE ELSE WILL. PCI REQUESTED TISCI TO CONTACT GIANCANA AND GET HIS DECISION ON THIS. ON OCTOBER 29 LAST TISCI CONTACTED PCI AND TOLD HIM THAT GIANCANA HAD DECIDED THAT PCI WILL RUN FOR REELECTION. ✓

PCI ALSO ADVISED THAT HE ALSO REQUESTED TISCI TO TELL GIANCANA THAT HE HAD BEEN CONTACTED BY TOP HOODLUMS JACK CERONE AND JOE GAGLIANO WITH A REQUEST WHICH PCI TURNED DOWN. PCI STATED THAT HE WANTED TO KNOW IF SUCH REQUEST CAME FROM GIANCANA AND WHETHER SUCH REQUESTS WERE TO BE HONORED BY PCI IF THEY DID NOT COME FROM GIANCANA THRU TISCI. TISCI THEREFORE TALKED TO GIANCANA AND RELAYED TO PCI THAT ALL ORDERS AND REQUESTS FOR PCI FROM GIANCANA WILL COME TO PCI THROUGH TISCI AND THAT ANY OTHERS NEED NOT BE HONORED. PCI UNDERSTANDS THAT GIANCANA REPRIMANDED CERONE AND GAGLIANO FOR DIRECT APPROACH TO PCI WITHOUT CLEARANCE FROM GIANCANA. THIS INFO SUBSTANTIALLY CONFORMS TO THAT PROVIDED BY CONFIDENTIAL SOURCE TWO WEEKS AGO. ✓
